# REFURNING STUDENT POLICY

- [] All students interested in returning to CIA must begin the process in the Admissions office and must talk directly to the Director of Admissions to receive the form required to begin the process.
- [] Foundation students may only return where they left off. Foundation students **may not** "skip a semester" without credit by portfolio review and a signature from the dean of Foundation.
- [] Students who leave in good standing the semester prior to entering a major must be reviewed by the appropriate department chair for admission into a major even if they were accepted into a major before leaving CIA.
- [] Students studying in a major who leave CIA in good standing are eligible to return to CIA in the semester and grade level where they left, with a portfolio review and signature from the appropriate department chair.
- [] Students wishing to return to CIA at a level higher than the one at which they left must provide a college transcript as well as have a portfolio review.
- [] Students who have studied at another accredited institution for one semester may be eligible to apply for transfer scholarship with a portfolio review of work done **outside of CIA** as well as with official transcripts from the other college(s).
- [ ] Students who were dismissed from CIA for academic reasons are **required** to meet with an Academic Advisor to find out if the appropriate corrective criterion has been met. The student will not be re-admitted until official transcripts or other paperwork are received and approved. Students who left CIA on academic warning or probation are required to meet with an Academic Advisor to clarify their academic status and to create a plan to return to good standing once re-admitted.
- [] Students who have an outstanding balance on their student account will not be re-admitted until the balance owed to CIA or AMS is at zero. Students with an outstanding balance will be required to meet with the Student Account Administrator.
- [] Students whose accounts have been placed with the collection agency must pay the collection agency in full before they can be re-admitted.
